Kind attention is invited to the Cabinet Note dated 09/09/2016. In accordance of this, Dept. of Revenue in concurrence of Dept. of Expenditure has created the following post at the level of Director and Deputy Secretary in the GST Council Secretariat: (copy enclosed)

2. Out of the 04 posts each at the level of Director and Deputy Secretary created, 50% of all the posts sanctioned are to be filled from Central Board of Indirect Taxes & Customs (CBIC) and the remaining 50% vacancy is to be filled by officers from State Governments. Accordingly, 02 vacancy at the level of Director and Deputy Secretary are to be filled by officers from the CBIC. At present, 02 officers working at the post of Director from the CBIC quota.


3. Currently, there are 02 vacancy at the level of Deputy Secretary from the CBIC quota. Further, Sh. Kshitendra Verma, IRS (C&IT) currently working as Director is under order of transfer to GST & CX Zone, Delhi Zone vide CBIC Office Order No115/2024 dated 18<sup>th</sup> July, 2024 and Sh. Saurav Suman Shardool, IRS (C&IT) working as Director has been temporarily attached with GSTAT, Delhi vide Department of Revenue Office Order 218/2024 dated 08<sup>th</sup> July, 2024, however the officer is still on the strength of GST Council Secretariat. Accordingly, as approved by the Competent Authority 01 post of Director and 01 post of Deputy Secretary are to be filled in GST Council Secretariat from CBIC quota.



4. In view of the above, it is requested that the vacancy circular to fill 01 post of Deputy Secretary and 01 post of Director may kindly be published on the CBIC "e-Pratiniyukti" (online deputation module) for filling up of posts at the earliest.


