**MINUTES OF THE STATE COORDINATION COMMITTEE MEETING OF
GST [CGST and SGST] ADMINISTRATION OF GUJARAT STATE, HELD
ON 28TH OF JUNE, 2024, CHAIRED BY PRINCIPAL CHIEF
COMMISSIONER, CGST, AHMEDABAD ZONE AND CHIEF
COMMISSIONER, SGST, GUJARAT.**

Meeting of the State Coordination Committee (SCC) comprising of CGST, Ahmedabad & Vadodara Zone, State GST Administration, Gujarat and DGGI, Ahmedabad Zonal Unit, for the quarter ending June, 2024 was held on **28.06.2024 at 11:30 AM** at the Conference Hall, 7th floor, GST Bhavan, Ambawadi, Ahmedabad through hybrid mode. The Gujarat State Coordination Committee was co-chaired by Ms. B. V. SivanagaKumari, Principal Chief Commissioner, CGST Ahmedabad Zone, Ahmedabad and Shri Samir Vakil, Chief Commissioner of SGST, Gujarat.

3. The actionable points are as under:

3.1. The Chair and Co-chair emphasized the importance of intelligence Sharing and decided to hold a meeting of all Additional / Joint Commissioners holding charge of Anti Evasion of CGST Ahmedabad Zone, Vadodara Zone, Zonal / Regional units of DGGI in Gujarat along with Additional Commissioners of SGST Enforcement at 4:00 PM on 12th July 2024, in the Conference room, 7th floor CGST Bhavan, Ahmedabad. It was also decided that during the said meeting, a presentation (10 minutes each) will be given by Ahmedabad Zone, Vadodara Zone, DGGI and SGST. Following officers shall be the Nodal Officers for preparing the presentation (i) Shri Amit Kumar Mishra, Additional Commissioner, CGST Ahmedabad Zone, (ii) Shri Milind Kavatkar, Additional Commissioner, SGST, (iii) Shri Rajesh Kumar, Additional Director, DGGI and (iv) Shri NakidiSrujan Kumar, Joint Commissioner, CGST Vadodara Zone. All executive CGST Commissioners and CGST Audit Commissioners will be present in the said meeting.

3.2. It was further decided that the CGST, SGST and DGGI will share the AE-II / gist of all cases booked by them in the last financial year (2023-24)

and first quarter of the current financial by 15th July 2024. The said information will be sent by the Additional commissioner enforcement SGST to the Additional commissioner CGST Ahmedabad zone / Additional director DGGI and vice versa. It was further decided to explore the possibility of creating a safe digital platform for sharing the information of cases booked in real-time basis.

3.3. It was further decided that a separate meeting will be convened on 12th July 2024 at 04:30 PM in the Conference room, 7th floor CGSTBhavan, Ahmedabad to discuss the issue regarding how to avoid multiplicity of enforcement actions on the taxpayers by both SGST & CGST u/s 67, 70 and 71 of respective Acts and to formulate SOP in the matter. The said meeting will be attended by all the Commissioners of CGST, representative from DLC, CGST Ahmedabad, officials from SGST & Standing Counsels of CGST so as to enable the department to defend its cases having common issues in High Court with more coordination.

4. As per the concluding para of point-2(A) of the OM dated 19.07.2023, issued by GST Council Secretariat **(Copy of OM enclosed)**, Chief Commissioner/Commissioners of CGST/SGST shall be co-chairs, they shall be Convener on rotational basis for one year each. In light of the aforesaid para of OM dated 19.07.2023, the SGST shall be Convener of state Coordination committee meetings on rotational basis for next one year. The next State Coordination Committee meeting for the quarter ending September, 2024 will be conducted by the SGST on 27th September 2024 at 11:30 AM.

5. The Meeting ended with the vote of thanks to both the Co-Chairs and the participants.
