It will also refer any issue requiring a change in Act/Rules/Notification/Form/Circular/Instruction, etc. to the GST Council Secretariat and the relevant Policy Wing of the CBIC.

The Committee shall meet once every quarter or more frequently as decided by the co-chairs.

The officers mentioned against serial no. VII in the above table will act as Secretaries of the GRC. The stakeholders may send their grievances/suggestions to the Secretaries of the Committee, who will place the same before the Committee. The Secretary of the Committee shall also submit a quarterly progress report to the GST council Secretariat as well as to the GST Policy Wing, CBIC.
